## ParkBH has exciting news for all who park in the City's public parking garages- PARCS Replacements & Upgrades!

The new PARCS equipment will include ticket dispensers, pay-on-foot machines, validation machines, monthly parking keycards, and other related hardware (life firewalls, network switches, and uninterruptible power supply units) and management software used to provide these services and operate the parking

facilities. These upgrades with the installation of License Plate Cameras will elevate the parking experience by streamlining customers' entry and exit, provide new opportunities to pay at new pay stations, new exit columns, and the ability to pay with mobile payment apps. Additionally, customers will improve operations and customer service with a 24/7 live parking operations center, make parking more accessible and more efficient for customers, improve auditing and credit card security to protect customers, and enable real-time data collection, which creates a more efficient parking experience for customers. The City operates 14-gated off-street public

parking structures, the Santa Monica 5 lots, a parking command center, and ancillary employee parking areas with approximately 5,942 parking spaces. The City's Parking Access and Revenue Control Systems (PARCS) is the parking equipment used at parking facilities to manage parking services and collect parking fees. The equipment, hardware, and software require an upgrade. To minimize the impact on the City's valued parking customers, the public parking facilities were prioritized and will be updated in a phased approach; for more information on the upgrade or implementation timeline, please visit [www.beverlyhills.org/parkbh](http://www.beverlyhills.org/parkbh).

## Annual Water Quality Report

The City is proud to provide high-quality drinking water in the 2021 calendar year. The Consumer Confidence Report (CCR) is an annual water quality report that requires water suppliers to inform customers where their water comes from, what is in their water, and any violations of standards that may have occurred. The U.S. Environmental Protection

Agency, under the Safe Drinking Water Act, mandates this annual report requirement. This report must be submitted to the State Water Resources Control Board's Division of Drinking Water (DDW) and our customers. ## New City Of Beverly Hills Drought Regulations

- **Two day per week watering:**
  - North of Santa Monica Blvd = Monday and Friday
  - South of Santa Monica Blvd = Tuesday and Saturday
- No watering (sprinklers or hose) between 9am-6pm
- Supplemental watering for trees allowed
- Violations will be issued for non-compliance
- 30% citywide water reduction goal
