1) Review of Foundation Donations Received to Date

Chief Financial Officer Don Rhoads provided an overview of all donations received to date (\$542,714.41 total). Staff received direction to approve and accept the \$401,906 donations received since the last meeting (for Police Department purchases and for the Lily Pond Phase of the Beverly Gardens Park Renovation project).

2) Proposed Update of By-Laws

Boardmember Stone indicated that the by-laws should be consistent with the Gift Acceptance Policy. Assistant City Attorney Enriquez provided clarification on the proposed changes. Article VI, Section 4B was updated to provide clarification on the Resident Directors terms of service. Article VII, Section 1 was expanded to allow for the Executive Committee (in between CBHCCF meetings) to accept unrestricted cash donations for the Beverly Gardens Park Renovation Project in an unlimited amount, and other donations of a value up to \$50,000. Additional clean-up language was proposed and approved.

3) Pledge Agreement
